



Dear Vendor,

It's that time of year again and the Mayflower Pembroke Welsh Corgi Club would like to extend an invitation to you to be a vendor at our annual specialty. The show committees are working hard to make this a special event with exhibitors coming from a wide area. This year Breed and Obedience classes will be held indoors at the Holiday Inn in Boxborough, MA from Wednesday, June 16 to Friday, June 18, 2010.

The booth space will be 10' x 10' at Boxborough. All spaces will be available on a first come basis. **Spaces are not reserved until the vendor receives confirmation from the vending chair.** Fees are as follows (*Please note the changes due to increased costs from last year.*):

Conformation: \$80 for all three days, 10'x10' space. Tables are available by pre-order only at \$18 each. Due to limited space, requests for multiple spaces will be granted only if space remains by May 28, 2010. Notice of acceptance will be sent.

Included with this fee will be a business card advertisement in the show catalogue and daily announcements highlighting individual vendors. To be included in the catalogue, contracts and business card ads must be received by May 5, 2010.

Donations for the silent auction at the banquet on Friday will be on a voluntary basis. Vendor's making a donation will receive special announcements and business card distribution at the banquet in a special display in the dining area. Please let the vending chair know if you are making a donation.

No vehicles will be allowed to pull into the vending area at Boxborough. Times for unloading and set-up on Wednesday will be sent via e-mail at least 1 week before the show.

Vendors will also need a sales tax number for the State of Massachusetts, proof of submission of a Transient Vendor License (TVL), and a business card for advertisement in the catalogue.
