Try to park reasonably close to the next vehicle(s) so that we can accommodate everyone. Your cooperation in this area will make the day go more smoothly. There is no parking space for RVs.

Please also note the following:

- The trial site will be available from 7:00 am until 1 hour after the event ends. Dogs may not be left overnight.
- No overnight parking
- Proof of rabies vaccination must be provided on request
- Please clean up after your dogs and dispose of the waste in the proper receptacle
- Dogs that are not in a secure enclosure must never be left unattended
- Dogs must be on lead except when being judged
- Un-entered dogs are not permitted in the trial areas
- Under no circumstances will dogs be permitted to disturb resting stock or interfere with another dog's performance in the trial areas

Directions

From the East: Route 20 West to Old Worcester Road. Make a U-turn at the light to Route 20 East. Go 0.5 miles and turn right onto Horne Homestead Road. #13 is on the right. Exhibitors should turn into the 2nd driveway and park where indicated.

From the West: I-90 East to I-84 to Route 20 East. Go about 10 miles and turn right onto Horne Homestead Rd. #13 is on the right. Exhibitors should turn into the 2nd driveway and park where indicated.
