- No dogs in restaurants or eating areas.
- Walk dogs in designated areas only. CLEAN UP AFTER YOUR DOG PLEASE.

Directions to Boxborough Regency:

**From the West** - Take Route 290. to Exit 26B (R to 495 North) toward Lowell. Take exit 28, Rte 111 East Boxborough - Turn left onto 111, turn onto Adams Place.

**From the South** - Take 495 North and follow above.

**From the East** - Take Rte 3 North, to exit 32A toward Lowell. Take R to 495 Exit, South and follow to Exit 28, Rte 111 Boxborough. Turn right onto Adams Place.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**THE SHOW COMMITTEE/SUPERINTENDENT** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

**CANINE COURTESY** All dogs shall be kept under control at all times. You are responsible for picking up after the animals in your care.

**To find out about any AKC event cancellations** call the AKC Event Cancellation Hotline 877-252-3229. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Refund and Cash award checks are void after 180 days and will NOT be re-issued.
